As part of it, the project intends to build a national-based full service payment system that is efficient and affordable..

Objective of the Assignment

The individual consultancy is intended to prepare technical requirements, including customization and localization, for the selection of the Central Securities Depository (CSD), the Money Market Trading System (MMTS) and the Foreign Exchange Trading System (FXTS) by the Bank of Mongolia (BOM). Moreover, the selected consultant is required to study and assess the current securities market developments and to prepare advisory report on the future development Mongolian securities market as suggesting appropriate organizational structure and necessary changes to related laws and regulations.

Scope of work

The consultant should prepare the requirements, technical specifications and a bidding document for the selection of CSD, MMTS and FXTS vendor.

Consultant is highly encouraged to focus on the following functionalities, when addressing the technical requirements:

- Central Securities Depository (CSD).
- Money Market Trading System (MMTS) and the Foreign Exchange Trading System (FXTS).

- Proficiency in English language and effective communication and interpersonal communications skills are mandatory.
