1. The Government of Mongolia received financing from the Asian Development Bank (ADB) toward the cost of **Payment System Modernization Project** and it intends to apply part of the proceeds of this loan to payment under the contract named above. Bidding is open to Bidders from eligible source countries of ADB.

2. The **Bank of Mongolia (BOM)** (“the Purchaser”) invites sealed Bids from eligible Bidders for the procurement of **Core Banking and General Ledger System (CBS/GL)** including O&M support for 36 months. CBS/GL system shall comply with international standard requirement.

3. **International Competitive Bidding (ICB)** will be conducted in accordance with ADB’s **Single-Stage: One-Envelope** bidding procedure and is open to all Bidders from eligible countries as described in the Bidding Document.

4. Only Bidders from eligible member countries with key qualifications given below should participate in this bidding:

- Net worth for the last three (3) years calculated as the difference between total assets and total liabilities should be positive;
- Minimum average annual turnover of USD 3,000,000 calculated as total payments received by the Bidder for contracts completed or under execution over the last three (3) years.
- The Bidder must demonstrate that its financial resources of availability of or access to liquid assets, lines of credit, and other finances sufficient to meet cash flow requirement which is USD 1,000,000.
- The Bidder shall have contractual experience of successful completion record as main supplier, of at least three (3) contracts within the last five (5) years each valued at least USD 2,000,000 for supply, implementation and support of CBS/GL.

Bidders should refer to the Bidding Documents for detailed qualification requirements.

5. Pre-bidding meeting shall be held on 17 October 2018 at 15:00 hours at the address in Para.7 below.
