

## **Invitation for Bids**

- 1. The Government of Mongolia received financing from the Asian Development Bank (ADB) toward the cost of Payment System Modernization Project and it intends to apply part of the proceeds of this loan to payment under the contract named above. Bidding is open to Bidders from eligible source countries
- 2. The Bank of Mongolia (BOM) ("the Purchaser") invites sealed Bids from eligible Bidders for the contract "Supply and Installation of Security Operation Center's System at NETC"
- 3. International Competitive Bidding will be conducted in accordance with ADB's Single-Stage: One-Envelope procedure and is open to all Bidders from eligible source countries of ADB as described in the Bidding Document.
- 4. Only eligible Bidders with the following key qualifications should participate in this bidding:
   Net worth for the last three (3) years (2017, 2018, and 2019) calculated as the difference between total assets and total liabilities should be positive;
  - Average annual turnover. Minimum average annual turnover calculated as total payments received by the Bidder for contracts completed or under execution over the last three (3) years (2017, 2018, and 2019) for lots are as follows:

Lot 1: USD 1,000,000 Lot 2: USD 200,000 Lot 3: USD 200,000

Bidders for multiple lots shall meet the aggregate requirements for lots stated above.

Cash-flow capacity. The Bidder must demonstrate that its financial resources of availability of or access to liquid assets, lines of credit, and other finances sufficient to meet cash flow

requirement which is at least:
Lot 1: USD 600,000
Lot 2: USD 120,000
Lot 3: USD 120,000

Bidders for multiple lots shall meet the aggregate requirement for lots stated above.

Contractual experience. The Bidder shall have contractual experience of successful completion record as main supplier, of at least two (2) contracts within the last three (3) years (2017, 2018, and 2019). Each contract amount for lots should be at least:

Lot 1: USD 800,000 Lot 2: USD 160,000 Lot 3: USD 160,000

Nature and complexity of contracts should be comparable to the subject contract. Bidders for multiple lots

shall meet the aggregate requirements for lots stated above.

• Litigation history. All pending claims, arbitration, or other litigation shall represent in total not more than 50 percent of the Bidder's net worth.
